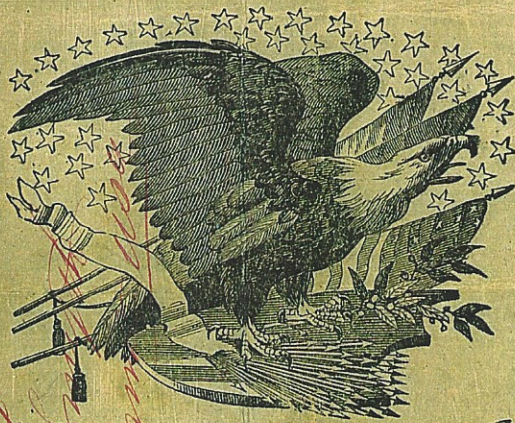


To all whom it may Concern.

Know ye, That Nelson Sluiker a
Corporal of Captain John M^c Dermotts
Company, (G.) First Regiment of Iowa Cavalry
VOLUNTEERS who was enrolled on the 10th day of August
one thousand eight hundred and Sixtyone to serve Three years or
during the war, is hereby Discharged from the service of the United States,
this 17th day of September, 1864, at Davenport
Iowa by reason of Expiring term of Entitlement
(No objection to his being re-enlisted is known to exist.)

Said Nelson Sluiker was born in Wallarof
in the State of Denmark, is Twentyone years of age,
Five feet Seven inches high, Fair complexion, Blue eyes,
Light hair, and by occupation, when enrolled, a Farmer
Given at Davenport Iowa this 17th day of
September 1864.

* This sentence will be erased should there be anything
in the conduct or physical condition of the soldier
rendering him unfit for the Army.
