After graduation, he helped his dad on the farm and did part-time work at the Fullerton Lumberyard. In April of 1951, he was drafted into the United States Army and spent two years serving his country stationed in Anchorage, AK. He was honorably discharged in 1953.



Vernon married Irene Kloewer in December of 1954. They began farming after their marriage and became parents to six children, Deborah, Anita, Sharon, Brenda, Dennis, and Glen. He farmed until they moved to Harlan in 1977. He belonged to the American Legion in Harlan and was a lifetime member of the Disabled American Vets. He had lived at the Westridge Apartments, the Baptist Home and later at Elm Crest Assisted Living, all in Harlan, until he moved to the Salem Lutheran Home in Elk Horn after being diagnosed with prostate cancer in 2001. He resided at Salem Lutheran Home until his death Dec. 2, 2006, at age 77 years,

nine months, and 18 days.

In addition to his parents, Vernon was preceded in death by a grandchild, Amy Michel, and three sisters, Virginia, Mary, and Audrey.
